The City has also extended the deadline for filing tax returns until July. The City does have a solid financial footing, pursuant to a long history of cooperation between City Council and City Administration to act in a fiscally conservative manner. This cooperation



is demonstrated by a record of City Administration's recommending and City Council approving budgets that fund the rainy day fund, as well as paying off long term debt as quickly as possible so as not to burden the City during a crisis such as this. I look forward to continuing to work with City Council to best plan for the future of Perrysburg during this crisis.

City Administration also continues to be in communication with federal, state, county and local governments and administrative agencies. Information exchange between these groups has been helpful to the overall success Ohio has achieved in flattening and extending the curve. We will continue these efforts and provide information to the community as quickly and as clearly as we can.

Finally, I want the community to know that the City Leadership is here for you. Contact members of City Council or the City Administration if you have any questions or concerns.
