Mr. Matuszak asked about awarding a contract that was over the estimate. Ms. Kabat explained that the Ohio Revised Code allows accepting a bid if it is not more than 10% over the estimate. She explained that dollars were budgeted for SR25/Roachton Road intersection improvements so we were prepared in case the grant money became available early. However, the project at SR199 and Eckel Junction has been a priority. Mr. Matuszak asked if that can be done without City Council involvement. Ms. Kabat explained that City Council is involved by approving the ordinance for a contract. She added that the capital improvements fund does not break out each project as a separate line item. Mr. VanHoozen said that this was last addressed seventeen years ago. He said that he hopes this increase is an enticement to get more people interested in running for office. Mr. McCarthy said that it does not fairly compensate for the amount of time, but for younger folks with families it will help offset the costs of running for and maintaining office. Mr. McCarthy said that it will keep us in line with other communities. Mr. Creps said that statewide we are in the middle and he said that he would distribute the Ohio Municipal League information regarding council salaries throughout the state. Mr. McCarthy stated that Council members would

have to be elected or re-elected to benefit from the increase. There was discussion regarding other options. Mr. Smith said that Columbus has a commission to take it out of the elected officials' hands. Mr. VanHoozen said that would be a charter issue and Mr. Creps added it to the list of possible topics for the next charter review.
