Now, if the said \_\_\_\_\_ shall comply with the City of Perrysburg Codified Ordinances, and shall promptly pay to said City of Perrysburg, any and all loss and damage it may sustain, either directly or indirectly, by reason of his making excavation for such construction and any and all repairs that are necessary within three (3) years from the date said construction was made, after having been given forty-eight (48) hours notice in writing by the Service-Safety Director that said repairs are necessary, then this obligation shall be null and void; otherwise to be and remain in full force and effect.
