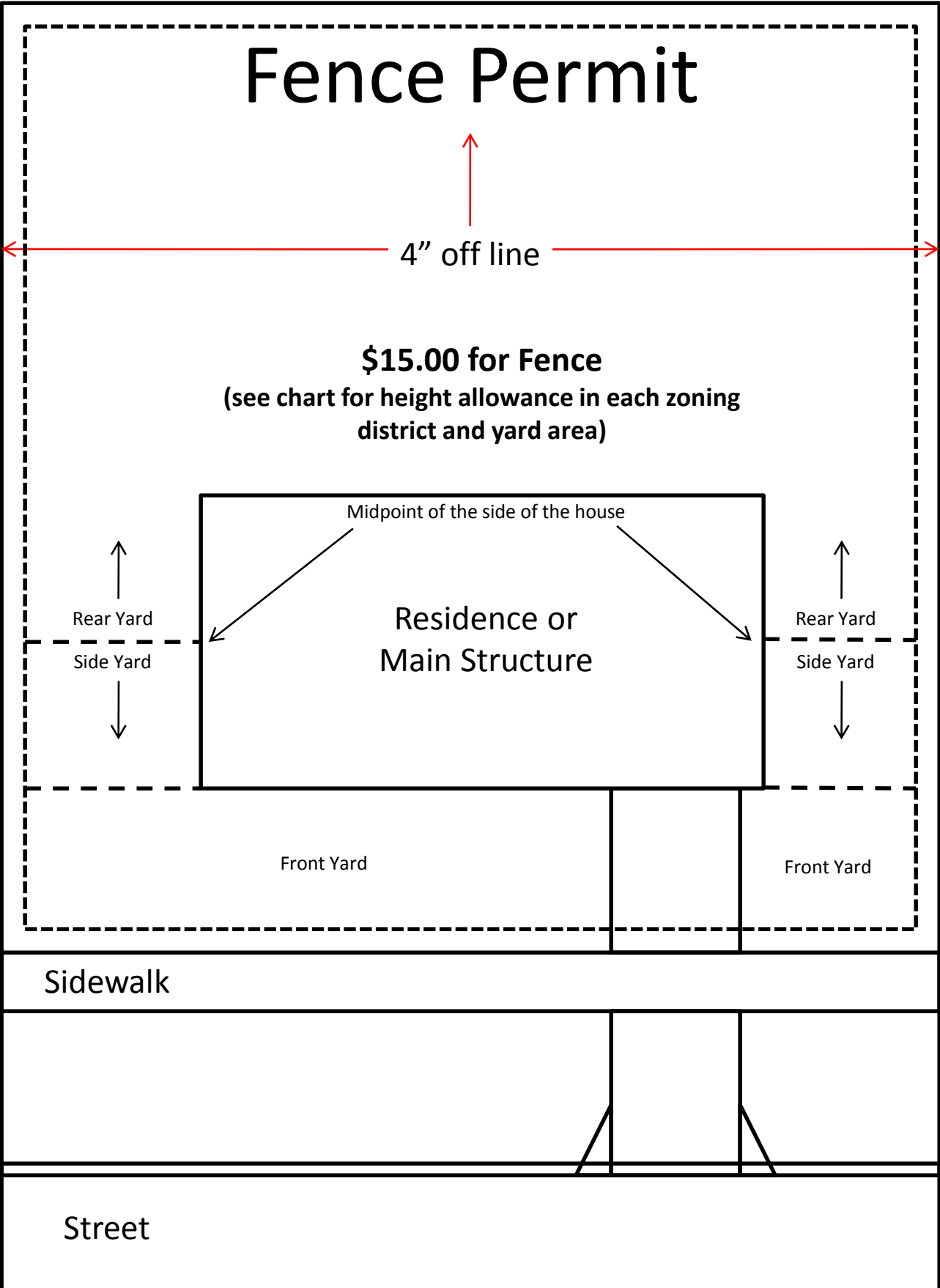

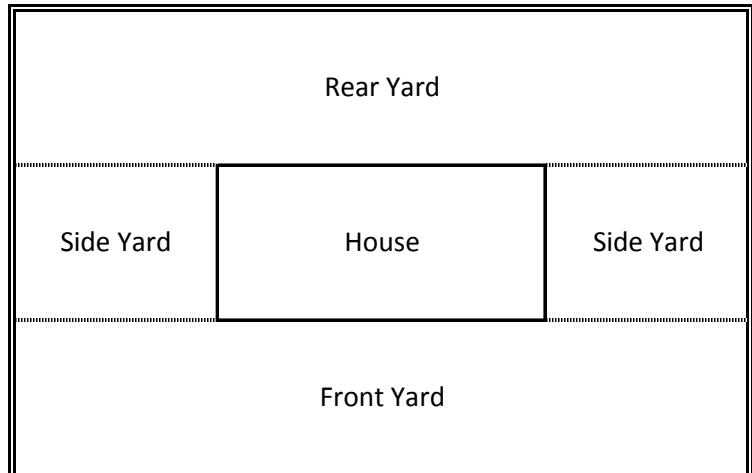

(Sketch can be attached). **NOTICE:** Some properties may have multiple front yards, depending on the properties location to roadways.

If the new fence will block free access of the water meter reader to the remote water meter, please call the Water Billing Office at 419-872-8055. The Water Division Personnel will relocate the remote meter to a position on the house exterior which allows the meter reader free access. **All fencing for pools shall feature self latching, self closing, lockable gates.**

Note: The undersigned states and affirms: that he/she is the property owner or agent for the owner; and that he/she understands and agrees that an inspection will be conducted by the City to verify the work performed for this permit; and that the City is authorized and permitted to enter the property to perform an inspection and otherwise review all work pursuant to this permit.
